The Board of Directors of Reining Canada, in accordance with the Reining Canada By-Laws, issues this Call For Nominations for the following Reining Canada Board positions commencing in 2008:

**President- Elect:**

This is a one-year position that automatically moves into the President role for one-year and on to the Past-President for one year. The nominee for the President-Elect must have served on prior term in any capacity on the Reining Canada Board.

**Secretary:** This is a two-year position. Knowledge and an interest in Governance would be an asset.

**Director-at-Large:** A new position that has a two-year term.

**Appel de candidatures!**

Reining Canada aimerait rappeler à ses membres qu'il est maintenant temps, pour ceux qui le souhaitent, de déposer les candidatures pour les élections prévues à l'Assemblée Générale de Reining Canada. Les nominations doivent être déposées, au plus tard, le soixantième (60) jours avant la fin du calendrier, soit le 1 novembre 2007. Il y a trois (3) postes d'ouvert pour les élections

**Président élu :** mandat de un (1) an. L'élu détient automatiquement le rôle de président et celui « d'ancien président » pour l'année suivante. Pour avoir l'opportunité d'être nommé sur ce poste, le membre doit avoir déjà servi sur le conseil d'administration de RC.

**Secrétaire :** mandat de deux (2) ans. Posséder des connaissances et des intérêts dans l'administration est un atout.

**Directeur « au loin » :** mandat de deux (2) ans, nouvelle position.

**Who is Eligible to be Nominated?**

In order to qualify as a candidate a person must be a current member in good standing with the Corporation. Definition: Member in Good Standing – shall mean a person who believes and follows the objectives of the corporation, has no financial obligation to the Corporation and who the Board has approved for membership.

**How to Nominate**

In order to appear on the ballot and be considered for office a member can be nominated in one of the following methods:

- A. Be nominated by the Board of Directors for an office. Not less than sixty (60) days prior to the end of the year the Board must submit to the Secretary a list of one (1) qualified candidate willing and able to hold office for every office of the Corporation.
- B. A member may be nominated by the membership in writing to Reining Canada not less than sixty (60) days prior to the end of the year. Said request must clearly state the name of the Member who is qualified and willing to stand for election, a current curriculum vitae, and the office desired and be signed by the candidate and not less than five (5) members in Good Standing.

Nomination documents will be accepted by November 1, 2007. Faxes are acceptable to (403) 945-9511. The Nominations & Governance Committee will place the names of all persons qualified on a ballot and cause said ballot to be sent to every member with the notification of the Annual General Meeting as per the RC Bylaws.
